Introduction:

The value of pet 'therapy' is widely accepted as a powerful aid to stimulation and communication. Studies have shown that the presence of companion animals can improve the well-being of children and lower the rate of anxiety, simply by making the environment happier, more enjoyable and less forbidding.

The rationale behind this decision:

- For the school to have a pet that was able to live as naturally as conditions would allow.
- For the animal to be properly cared for outside of the school day.
- To have a pet that the children could interact with and also be of benefit to the children's social and emotional development.
- It is accepted that interacting with animals is not appropriate for all children but for some it has the potential to provide many positive benefits.
- Any parent who does not want their child to interact with 'Monty' is invited to write to Miss Child's and inform her of their wishes.
- There are no diseases associated with the puppy as her vet will be responsible for vaccinations, including rabies and completing regular health checks and necessary treatment. A copy of Monty's health records will be updated and kept in school.
- Monty will also be insured.

The risk assessment below is a working document and will be checked annually by key staff and the governing body.

All staff are aware, adhere to and have read the Therapy Dog policy. It is the member of staffs responsibility not to leave the dog unsupervised around children.		
	The dog will undergo formal training from the age of 18 weeks with an experienced dog trainer. Risk of scratching and biting will reduce and the risk assessment will be reviewed as he progresses through his weekly training. All staff will have been introduced to the dog and expectations of having a school dog. He will attend the vets regularly to ensure he is in good health and that his claws are kept short.
